Personal data we process

Snijders Douane Agenten processes your personal data because we supply our services to you and/or you supply services to us. This privacy statement is not applicable to the processing of data of employees. A separate policy has been drafted for this purpose.

The purpose to and on what ground we process personal data

Snijders Douane Agenten processes your personal data solely for the following purposes:

- The processing of payments
- The establishment and performance of agreements
- Communication by phone or email if this is necessary for the purpose of performing our services
- Handling questions and complaints
- The delivery of goods and services
- Conducting application procedures
- Snijders Douane Agenten also processes personal data if we are under the legal obligation to do so, for example data necessary to complete our tax declarations

Automated decision-making

Snijders Douane Agenten does **not** make decisions based solely on automated processing regarding matters that may have consequences for individuals. This concerns decisions that are made by computer programmes or systems without intervention of an individual (for example an employee of Snijders Douane Agenten). Snijders Douane Agenten uses the following computer programmes and systems:

Sprinter

Software for the purpose of processing dossiers. Data is only accessible to authorized users, after logging in.

Exact on-line

Administrative software for the purpose of the financial administration. Data is only accessible to authorized users, after logging in.

4M-Focus

Supporting software for management fort he purpose of registering processes, organisation, issue management, risk management and suppliers. Accessible to users after logging in.

Outlook/Office 365

Email and address data of the network is stored in this software for the purpose of communication. Data is only accessible to authorized users, after logging in.

Retention period of personal data

Snijders Douane Agenten stores your personal data no longer than strictly necessary for the purposes for which your data is collected. This is the legal retention period of 7 years in consideration of the settlement of tax matters and/or legal basis.

Sharing of personal data with third parties

Snijders Douane Agenten solely provides personal data to third parties if this is necessary for the performance of our agreement with you or to comply with a legal obligation.

Cookies, or comparable techniques we use

Snijders Douane Agenten only uses technical and functional cookies, We might also use cookies for analytical purposes without any privacy threats.. A cookie is a small text file which is created at first visit of our site. This file will be stored on your computer. The cookies we use are required for the technical functionality of our website and ease of use for visitors by registration of your preferences. We can also use them to optimise our website. In your internet browser you can find options to disable or remove cookies.



Review, modify or delete personal data

You are entitled to review your personal data, to rectify it or to have it deleted. Furthermore, you are entitled to revoke any permission for the processing of data or to object to the processing of your personal data by Snijders Douane Agenten, and you have the right to data portability. This means that you may submit a request to have the personal data that we have acquired regarding your person send to you or another organisation mentioned by you in a computer file.

You may submit a request to review, modify or delete your personal data, to exercise your right to data portability, to withdraw your permission for the processing of your personal data or to file your objection to the processing of your personal data by sending it to info@snijdersdouaneagenten.nl.

To ensure that the request to review your personal data has been submitted by you, we ask you to append a copy of your proof of identification to your request. Please black out your passport picture, MRZ (Machine Readable Zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (for Dutch identification documents: *Burgerservicenummer, BSN*), for the purpose of protecting your privacy. We will respond to your request as soon as possible, but within four weeks at the latest.

Furthermore, Snijders Douane Agenten would like to point out that you have the possibility to file a complaint with the national Supervisor, the Data Protection Authority (*Autoriteit Persoonsgegevens*).
